Standards of Ethical Conduct for the
PHYSICAL THERAPIST ASSISTANT

- Standard #1: Physical therapist assistants shall respect the inherent dignity, and rights, of all individuals.
- Standard #2: Physical therapist assistants shall be trustworthy and compassionate in addressing the rights and needs of patients.
- Standard #3: Physical therapist assistants shall make sound decisions in collaboration with the physical therapist and within the boundaries established by laws and regulations.
- Standard #4: Physical therapist assistants shall demonstrate integrity in their relationships with patients, families, colleagues, students, other health care providers, employers, payers, and the public.
- Standard #5: Physical therapist assistants shall fulfill their legal and ethical obligations.
- Standard #6: Physical therapist assistants shall enhance their competence through the lifelong acquisition and refinement of knowledge, skills, and abilities.
- Standard #7: Physical therapist assistants shall support organizational behaviors and business practices that benefit patients and society.
- Standard #8: Physical therapist assistants shall participate in efforts to meet the health needs of people locally, nationally, or globally.
